Dear Member Councils

Welcome to the latest edition of my Bulletin, which I hope you continue to find helpful. Feedback is always welcome (e-mail chief.executive@kentalc.gov.uk) so that I can refine it for the next edition.

- **Government Confirms that referendum principles will NOT be extended to Parish Councils for 2020/2021:** On 6 February, Government confirmed in paragraph 13 of “The Referendums Relating to Council Tax Increases (Principles)(England) Report 2020/21 that referendum principles would not be extended to Parish Councils for that year.
- **NALC Expands its services with a new suite of HR resources:** NALC has launched a new suite of HR resources to help local councils on a range of employment matters. The resources include templates on numerous employment policies that you can tailor to your council's needs, alongside how-to guides and notes to implement the policies. These cover the full range of employment matters such as annual leave, lone working, training and many more. The resources were produced in collaboration with HR Services Partnership. - **Government consultation on strengthening police powers to tackle unauthorised encampments** – as highlighted in the November, December 2019 and January 2020 issues, on Tuesday 5 November Government launched a consultation on new powers to criminalise unauthorised encampments, see <https://www.gov.uk/government/consultations/strengthening-police-powers-to-tackle-unauthorised-encampments>. We would encourage all member councils to respond to this consultation. The closing date is **4 March 2020**.
- **National Transport and Highways Survey 2019/20** – Councils across the UK are asking residents to tell them what they think of transport and roads services in their area. The National Highway and Transport Network have provided 6 independent surveys. You do not have to take them all. Each survey will only take a few minutes of your time. They are asking for views on accessibility; roads maintenance; public transport; road safety; tackling congestion; and walking and cycling. The surveys close on **29 February 2020**. - **Lower Thames Crossing Supplementary Consultation:** Highways England has issued an 8-week supplementary consultation which provides the opportunity to have your say on the latest changes to the project that have been made after detailed analysis of the 29,000 responses Highways England received during the last consultation in 2018, and new technical information becoming available following surveys and ground investigations. - **Kent County Council (KCC) Strategic Statement – 5 Year Plan:** KCC has issued a consultation on its 5-year draft plan, which is the flagship strategy for the Council. It aims to unite the Council with clear outcomes and objectives. The closing date for responses to KCC is **17 February 2020**.
